American Literary Historiography in the United States and Italy Modernizing Costume Design, 1820-1920

This book investigates the narrative of nationhood during the Italian Risorgimento and its ability to reach a new and wider audience. In Italy, an extraordinary emotional excitement pervaded the struggle for national independence, suffusing the speeches and actions of patriots. This book shows how this ardour borrowed the tones, figures and spectacular nature of the melodramatic imagination feeding the theatre and literature of the time, and how it could resonate with a largely uneducated audience. An important contribution to the new historiography on the Italian Risorgimento and on nineteenth-century nationalism in Europe, it offers a fresh perspective on the public sphere during the Risorgimento, focusing on the transnational links between political mobilisation and the growth of new media and burgeoning mass culture.

Our natural world has been irretrievably altered by humans, for humans. In a historical period of international and global frames of literary investigation, *In Their Own Terms* is a timely and valuable contribution to cross-cultural forms of dialogue between non-American modes of analysis and US American literary studies. It is a wide-ranging and provocative look into American literary historiography that engages readers in analytical examinations of US literary histories considered landmarks in their field, from the early nineteenth-century work of Samuel L. Knapp to the newly completed Cambridge volumes. It focuses on texts that have had a decisive influence in constructing dominant understandings of American literature, its various genres, significant historical periods, and major writers, both inside and outside the United States. For the first time, this work compares and contrasts the tradition of US literary historiography with Italian histories of American literature. Characterized as they are by the particularities of the Italian cultural scene, these histories have always been conversant with US literary

historiography, beginning with Gustavo Strafforello in 1884 and continuing in Agostino Lombardo's most recent series. *In Their Own Terms* cogently argues that American literary histories, regardless of the different critical and theoretical principles on which they are based, have invariably played an important role in national cohesion and in articulating an autonomy that is cultural as well as academic.

«Qui stretti in famiglia giuriamo guerra eterna di sterminio a quelle belve vestite di umana forma, ai crudeli che questa terra dilaniano che, non sazi dei nostri tesori, il sangue stesso ci succhiano. Vendetta! Vendetta! Lo giuriamo!». È una pagina di un mélodel 1848, dove una giovinetta di forte tempra morale giura di combattere il nemico austriaco che opprime, sevizia, perseguita la patria succube da secoli dello straniero. Una straordinaria esaltazione percorre in Italia

le battaglie risorgimentali, mentre il lessico delle emozioni e dei sentimenti invade la politica. Persino i più moderati tra i patrioti utilizzano linguaggi, narrazioni, gestualità che risuonano di enfasi e di estremismo etico e si richiamano a quella immaginazione melodrammatica che, dalla fine del Settecento, attraversa in tutta Europa il teatro e la letteratura di finzione. È dunque sulle scene di Parigi, di Londra e di Milano che inizia il percorso di questo volume, perché è lì che per la prima volta si propongono testi insieme lacrimevoli e spettacolari, adatti a un pubblico largo e non acculturato. Ma è nell'Italia del 1848 che il melodramma della nazione esprime al meglio le sue potenzialità, permeando di sé i discorsi e la comunicazione politica, come le pratiche e i corpi dei patrioti, in un crescendo di pathos e teatralità. With chapters on theatre and opera, architecture and urban planning, the medieval revival and the rediscovery of the Etruscan and Roman past, *The Politics of Culture in Liberal Italy* analyzes Italians' changing relationship to their new nation state and the monarchy, the conflicts between the peninsula's ancient elites and the rising middle class, and the emergence of new belief systems and of scientific responses to the experience of modernity.

Annie Holt identifies the roots of contemporary Euro-American practices of costume design, in which costumes are an integrated part of the dramaturgy rather than a reflection of an individual performer's taste or status. She argues that in the period 1820-1920, as part of the larger project of modernism across the artistic and cultural field, the functions of "clothing" and "costume" diverged. Onstage apparel took on a more specific semiotic task, acting as a fresh channel for the flow of information between the

performer, the literary text, and the spectator. *Modernizing Costume Design* traces how five kinds of artists – directors, performers, writers, couturiers, and painters – made key contributions to this new model of costume design. Holt shows that by 1920, costume design shifted in status from craft to art.
