The Visual Notetaking Strategy is defined as the process of representing information non-linguistically. This means through drawings or pictures. It can be simple, using sketches or doodles, or more complex, using mind mapping or concept maps as representations. Notetaking is a skill that takes some practice, but it makes a tremendous difference in grades and - more importantly - improves the ability to learn and feel successful.

In this view, learners make sense of the world by forging connections between new ideas and those that are part of their existing knowledge base. For most students, that knowledge base is riddled with a host of naïve notions, misconceptions and alternative conceptions they have acquired throughout their lives. To a considerable extent, the job of the teacher is to coax out these ideas; to help students understand how their ideas differ from the scientifically accepted view; to assist as students restructure and reconcile their newly acquired knowledge; and to provide opportunities for students to evaluate

what they have learned and apply it in novel circumstances. Clearly, this prescription demands far more than most college and university scientists have been prepared for.

Therefore, the early shelter and protection offered by an established firm is lost after a few years when the developing lawyer is required to either leave the firm or develop a pool of clients that generate sufficient profits for the firm to justify the lawyer's salary. In essence, the lawyer has to develop the lawyer's own "profit

center" or the lawyer's own "solo firm" within the firm. Either way, the lawyer has to know how to start a practice and thrive. This book will help striving lawyers get on the path to success.
