This is a challenging problem-solving book in Euclidean geometry, assuming nothing of the reader other than a good deal of courage. Topics covered included cyclic quadrilaterals, power of a point, homothety, triangle centers; along the way the reader will meet such classical gems as the nine-point circle, the Simson line, the symmedian and the mixtilinear incircle, as well as the theorems of Euler, Ceva, Menelaus, and Pascal. Another part is dedicated to the use of complex numbers and barycentric coordinates, granting the reader both a traditional and computational viewpoint of the material. The final part consists of some more advanced topics, such as inversion in the plane, the cross ratio and projective transformations, and the theory of the complete quadrilateral. The exposition is friendly and relaxed, and accompanied by over 300 beautifully drawn figures. The emphasis of this book is placed squarely on the problems. Each chapter contains carefully chosen worked examples, which explain not only the solutions to the problems but also describe in close detail how one would invent the solution to begin with. The text contains a selection of 300 practice problems of varying difficulty from contests around the world, with extensive hints and selected solutions. This book is especially suitable for students preparing for national or international mathematical olympiads or for teachers looking for a text for an honor class.

Toric varieties form a beautiful and accessible part of modern algebraic geometry. This book covers the standard topics in toric geometry; a novel feature is that each of the first nine chapters contains an introductory section on the necessary background material in algebraic geometry. Readers of this book should be familiar with the material covered in basic graduate courses in algebra and topology, and to a somewhat lesser degree, complex analysis. In addition, the authors assume that the reader has had some previous experience with algebraic geometry at an advanced undergraduate level. The book will be a useful reference for graduate students and researchers who are interested in algebraic geometry, polyhedral geometry, and toric varieties.

There is a particular fascination when two apparently disjoint areas of mathematics turn out to have a meaningful connection to each other. The main goal of this book is to provide a largely self-contained, in-depth account of the linkage between nonassociative algebra and projective planes, with particular emphasis on octonion planes. There are several new results and many, if not most, of the proofs are new. The development should be accessible to most graduate students and should give them introductions to two areas which are often referenced but not often taught. On the geometric side, the book introduces coordinates in projective planes and relates coordinate properties to transitivity properties of certain automorphisms and to configuration conditions. It also classifies higher-dimensional geometries and determines their automorphisms. The exceptional octonion plane is studied in detail in a geometric context that allows non-division coordinates. An axiomatic version of that context is also provided. Finally, some connections of nonassociative algebra to other geometries, including buildings, are outlined. On the algebraic side, basic properties of alternative algebras are derived, including the classification of alternative division rings. As tools for the study of the geometries, an

axiomatic development of dimension, the basics of quadratic forms, a treatment of homogeneous maps and their polarizations, and a study of norm forms on hermitian matrices over composition algebras are included.
