The literature of the Peninsular War is rich with vivid source material – letters, diaries, memoirs, and dispatches – but most of it was written by British soldiers or by the French and their allies. As a result the history and experience of the Portuguese forces – which by 1812 composed close to half of Wellington's Army – have been seriously under-represented. That is why this pioneering book, which publishes for the first time in English the after-action reports written by the commanders of Portuguese battalions, regiments and brigades, is so important. For these detailed, graphic firsthand accounts give us a fascinating insight into the vital contribution the Portuguese made to the allied army and shed new light on the struggle against the French in the Iberian Peninsula. The authors provide an introduction tracing the history of the Portuguese Army prior to the Salamanca campaign of 1812, while tracking its organizational changes and assignment of commanders from

It is difficult to find the moment when the idea for a book is first born. For this book, the basic concept was probably born during conversations I had in Parma, Italy, with Dr. Riccardi of the University of Naples and Dr. Jenkins of the University of Toronto (Canada). Later, in a conference room at the University of Verona (Italy) School of Medicine, I had a day-long meeting with Drs. Bosello and Cominacini of the University of Verona, and Drs. Jenkins and Riccardi and their co-workers. After an intense working day, the general plan of this book was completed. The title Mediterranean diets rather than diet was appropriately chosen as there is more than one Mediterranean diet, a point discussed in chapter 1. This chapter focuses on the definition of a Mediterranean diet and no matter what the reader's interest may be, it is imperative that this first chapter be carefully read. We should always remember that there are-from a preventive medicine

point of view-good and poor Mediterranean diets. The best example is probably the difference between the high olive oil, high carbohydrate, low meat diet of southern Italy and the high saturated fat, higher meat diets of the northern Italians. Prevalence of disease parallels these differences. Chapter 2 covers some ancient history in an easy-to-read manner that is instructional as well as fascinating even for the nonmedical scientist or the nonhistorian.

America's Forgotten Colony examines private US citizens' experiences on Cuba's Isle of Pines to show how American influence adapted and endured in republican-era Cuba (1902-58). This transnational study challenges the notion that US territorial ambitions waned after the nineteenth century. Many Americans, anxious about a 'closed' frontier in an industrialized, urbanized United States, migrated to the Isle and pushed for agrarian-oriented landed expansion well into the twentieth century. Their efforts were stymied by Cuban resistance and reluctant US policymakers. After decades of tension, however, a new generation of Americans collaborated with locals in commercial and institutional endeavors. Although they did not wield the same influence, Americans nevertheless maintained a significant footprint. The story of this cooperation upsets prevailing conceptions of US domination and perpetual conflict, revealing that US-Cuban relations at the grassroots were not nearly as adversarial as on the diplomatic level at the dawn of the Cuban Revolution.

Log-domain and translinear filters provide a competitive alternative to the challenges of ever increasing low-voltage, low-power and high frequency demands in the area of continuous-time filters. Since translinear filters are fundamentally large-signal linear, they are capable of realizing a large dynamic range in combination with excellent tunability characteristics. Large-signal linearity is achieved by exploiting the accurate exponential behavior of the bipolar transistor or the subthreshold MOS transistor. Comparisons are made with respect to alternative analysis and synthesis methods presented in the literature. The theory is illustrated and verified by various examples and realizations. **Dynamic Translinear and Log-Domain Circuits: Analysis and Synthesis** is an excellent reference for researchers and circuit designers, and may be used as a text for advanced courses on the topic.

The Roman empire tends to be seen as a whole whereas the early middle ages tends to be seen as a collection of regional histories, roughly corresponding to the land-areas of modern nation states. As a result, early medieval history is much more fragmented, and there have been few convincing syntheses of socio-economic change in the post-Roman world since the 1930s. In recent decades, the rise of early medieval archaeology has also transformed our source-base, but this has not been adequately integrated into analyses of documentary history in almost any country. In *Framing the Early Middle Ages* Chris Wickham combines documentary and archaeological evidence to create a comparative history of the period 400-800. His analysis embraces each of the regions of the late Roman and immediately post-Roman world, from Denmark to Egypt. The book concentrates on classic socio-economic themes, state finance, the wealth and identity of the aristocracy, estate management, peasant society, rural settlement, cities, and exchange. These give only a partial picture of the period, but they frame and explain other developments. Earlier syntheses have taken the development of a single region as 'typical', with divergent developments presented as exceptions. This book takes all different developments as typical, and aims to construct a synthesis based on a better understanding of difference and the reasons for it.

Abstract: Nine papers developed from a 1981 international workshop summarize current knowledge of the role of proteins (and amino acids) in lipid metabolism and atherosclerosis for nutritionists, clinicians, and other health professionals. The topics range from studies on lipid metabolism and experimental atherosclerosis in animals (rats, rabbits, swine), to effects of proteins on human serum lipids and lipoproteins. Other papers discuss the effects of soy protein and casein, influences of dietary protein on serum cholesterol, and the immunological aspects of atherosclerosis. The results of these studies indicate that dietary protein can make a significant contribution to atherosclerosis, that soy protein produces lower serum cholesterol levels than casein (the dynamics of which are described), and that diets containing animal protein are generally more cholesterolemic and atherogenic (in rabbits, specifically) than diets containing vegetable protein. The protein effect can be modified by other dietary components (e.g., fiber, fat). Other findings (e.g., the role of dietary protein in the immunological aspects of atherosclerosis) also are reported. (wz).

Er besitzt mit seinen zwei parallelen Start- und Landebahnen (Abstand 2300 m) einen Koordinierungseckwert von 90 Flugbewegungen / Stunde und hat somit die größte Kapazität in Deutschland, zumindest was das Bahnsystem angeht. Verkehrszahlen: Der Flughafen ist mit einem durchschnittlichen Wachstum von 7 % (bei Fracht 11 %) einer der am schnellsten wachsenden Luftverkehrsdrehscheiben in Deutschland. Konzernstruktur: Die Flughafen München GmbH hat seit dem 01.01.2005 eine neue Konzernstruktur. Sie wurde im Rahmen des Strategie- und Ergebnisverbesserungsprojektes M-Power eingeführt.
