The first volume focuses on the use of the method for linear problems. First, the strong form of the problem (governing differential equations and boundary conditions) is formulated. Subsequently, a weak form of the governing equations is established. Practical aspects of FEA and advanced topics, such as reduced integration procedures, mixed finite elements and verification and validation of the FEM are also

discussed. Provides detailed derivations of finite element equations for a variety of problems. Incorporates quantitative examples on one-dimensional and multi-dimensional FEA. Provides an overview of multi-dimensional linear elasticity (definition of stress and strain tensors, coordinate transformation rules, stress-strain relation and material symmetry) before presenting the pertinent FEA procedures.
